**EVALUATION REPORT**

Bihar State Education Finance Corporation Ltd., Patna had invited online applications for recruitment of professionals for different contractual positions through advertisement dated 30<sup>th</sup> July, 2019 published in various State and National daily newspapers, namely Dainik Jagran (Patna, Bhagalpur & Muzaffarpur Edition), Hindustan (Patna, Muzaffarpur & Gaya Edition), The Telegraph (Kolkata Edition), Prabhat Khabar (Patna, Muzaffarpur & Bhagalpur Edition), The Pioneer (Delhi), The times of India (Patna Edition). Online applications were received from 1<sup>st</sup> August, 2019 to 22<sup>nd</sup> August, 2019 till 5.00 PM.

2. The Online Application Software was prepared by National Informatics Centre (NIC), Patna and was hosted on the website <http://finance.bih.nic.in> of Finance Department, Govt. of Bihar. The number of online applications accepted by the online application software is as follows:

3. The online applications accepted for the position of Executive Assistant enlisted in the advertisement were evaluated by the Software on pre-determined marking/evaluation criteria on the basis of essential and preferable educational and professional qualifications mentioned in Para-6 of the aforesaid advertisement and accordingly the list was prepared by the software and the Committee in order of merit on the basis of marks allotted.

4. As large number of online applications were received for the position of Executive Assistant and as per provisions contained in Para-5, that short listed candidates for all positions are to be called for Typing Test and Interview in the ratio of 1:5, (if the total marks allotted by the software for more than one candidate are same), then same marks allotted candidates are considered as one candidate and A four member Screening Committee of Bihar State Education Finance Corporation Limited, Patna was constituted vide Memo No.-1751 dated 27-08-2019.

5. The Third and Fourth meeting of the aforesaid Screening Committee were held on 24th September, 2019 and 11th October, 2019, decided the number of online applications to be screened and shortlisted, as per the marks allotted by the software and the Committee against the position of Executive Assistant, submitted report to Bihar State Education Finance Corporation Ltd., Patna.

6. During the course of perusal, evaluation report of Executive Assistant, of the Screening Committee, it was found that several online applications which were accepted by the software till the prescribed last date and time of online application, the educational qualification/post qualification certificates were either not uploaded or were illegible due to various reasons. As a result, shortlisted candidates for the post of Executive Assistant were intimated through various e-mail dated 26-09-2019, 27.09.2019, 28.09.2019, 30.09.2019, 01.10.2019 and 09.10.2019 to send their requisite documents through e-mail to BSEFCL till 6:00 PM on 10-10-2019. The short listed candidates on receiving the aforesaid e-mail submitted the requisite educational qualification/post qualification certificates etc., the details of which is as follows :

The Screening Committee submitted its Final Report to the Bihar State Education Finance Corporation Ltd., Patna.

During the course of perusal of evaluation report of the Screening Committee, it was found that the online applications which were accepted and shortlisted by the software on basis of pre-determined making/evaluation criteria, were allotted incorrect marks due to technical error hence the same has been corrected. The screening Committee submitted its Final report to Bihar State Education Finance Corporation Ltd., Patna.

9. The Evaluation Report of Screening Committee is attached as ANNEXURE-I. All candidates enlisted in ANNEXURE-I are requested to send their objections, if any **on e-mail ID- bsefcl@gmail.com till 05:00 PM on 21.10.2019** which will be analysed and final list of short listed candidates will be prepared by the BSEFCL. No request regarding any objection will be entertained by the BSEFCL after the prescribed last date and time.
