IMPORTANT NOTICE

With reference to Intimation Letter vide Memo No. BSEFCL(Est.)-08/2018-303 dated 28.09.2018 published on the website <http://finance.bih.nic.in/> of Finance Department, Govt. of Bihar, the shortlisted applicants for the post of Computer Operator-cum-Typist, all the 16 shortlisted applicants were called for the Typing Test in Hindi and English on 10.10.2018 at 10.00 am.

2. Out of 16 shortlisted applicants, only 10 applicants appeared in the typing test with proficiency in English and Hindi typing with a minimum typing speed of 30 wpm as mentioned as prescribed in the Advertisement dated 26.06.2018 of BSEFCL, Patna. Finally only three applicants qualified in both English and Hindi typing test simultaneously with minimum typing speed of 30 wpm for the post of Computer Operator-cum-Typist. The result of Typing Test is enclosed as ANNEXURE-1 along with this Important Notice.

The successful candidates in both Hindi and English Typing Test namely Ms. **Neetu Kumari (Application ID-OPT/0000478)**, Mr. **Alok Prakash (Application ID-OPT/0001283)** and Mr. **Abhishek Kumar (Application ID-OPT/0001549)** is being called for interview on **05.11.2018 (Monday) 11:00 AM** at Finance Department (First Floor), Main Secretariat, Patna-800015 in the chamber of Special Secretary, Finance Department & CEO-cum-MD, Bihar State Education Finance Corporation Ltd., Patna.

4. If you are presently serving in Central or State Government/Semi Government/Autonomous Departments including Board/Corporation/ Mission/ Society/Company/ PSU's, you should bring original "No Objection Certificate" issued by the employer organisation to attend the interview.

5. **Your candidature is Provisional.** You must, therefore, ensure that you fulfill all the conditions of eligibility laid down in the advertisement. **If, at any stage, it is found that you do not fulfill any of the conditions of eligibility, your candidature will be cancelled and no appeal against such cancellation will be entertained.** The fact that you have been called for interview does not confer any right on you to be treated as eligible in all respects for appointment or to be considered for interview. To avoid any

disappointment at a later stage, you are advised to recheck whether you meet all the eligibility criteria laid down on the cut-off date prescribed for the post.


6. **No change in date, time and venue of the Interview will be allowed** for any candidate under any circumstances. **In case you fail to attend the interview, it will be presumed that you are not interested in the post and your candidature will be treated as 'Cancelled'**. No further correspondence will be entertained in this regard.
