With reference to the Important Notice vide Memo No. BSEFCL (Est.) 08/2018-275 published on the website of Finance Department regarding shortlisted applicants for the post of Computer Operator-cum- Typist, all the 16 shortlisted applicants (As mentioned in Annexure-1) are being called for the Typing Test in Hindi and English as per programme given below.

All shortlisted applicants are required to be present at the specified time and venue along with Photo Identity Card (i.e. Aadhaar Card/Passport/Voter Card/ Driving License/PAN Card), Two Colour Photographs and One set of Self-attested copies of all the relevant Documents/Certificates along with Experience Certificate indicating start and end of employment period with the particular organisation.

3. If you are presently serving in Central or State Government/Semi Government/Autonomous Departments including Board/Corporation/Mission/ Society/Company/PSU's, you should bring original "No Objection Certificate" issued by the employer organisation to attend the Test.

4. Your candidature is Provisional. You must, therefore, ensure that you fulfill the conditions of eligibility laid down in the advertisement. If at any stage, it is found that you do not fulfill any of the conditions of eligibility, your candidature will be cancelled and no appeal against such cancellation will be entertained. The fact that you have been called for Typing Test does not confer any right on you to be treated as eligible in all respects for appointment or to be considered for test. To avoid any disappointment at a later stage, you are advised to recheck whether you meet all the eligibility criteria laid down on the cut-off date prescribed for the post.

5. No change in date, time and venue of the Typing Test will be allowed for any candidate under any circumstances. In case you fail to attend the test, it will be presumed that you are not interested in the post and your candidature will be treated as 'Cancelled'. No further correspondence will be entertained in this regard.

6. The BSEFCL will not be responsible for late/non-receipt of this e-mail due to technical error or delay or any other reason beyond the control of the BSEFCL.

7. BSEFCL reserves the right to take action, if false documents are produced or required documents are not produced by the applicant at any time of the test.

8. Canvassing in any form will result in cancellation of your candidature.


9. No TA/DA will be admissible for attending the Typing Test.


